GODSTONE UNITED CHARITIES REPORT FOR ANNUAL PARISH ASSEMBLY OF GODSTONE PARISH COUNCIL 30 September 2023

Godstone United Charities (GUC) is a Registered Charity with the Charities Commission. There is a total of 6 Trustees. Generally, appointments are made by the Parish Council, GUC Committee and the Clergy and every effort is made to ensure that the whole Parish (i.e. Godstone, South Godstone and Blindley Heath) is represented. Helen Simmons has recently agreed to take over from Gill Rhodes, who after many years has decided to retire while Candy Edwards took over from Terry Tomlinson last year. You will see also that Pat Bamforth is no longer the Clerk, her position has been filled by Trisha Miller, whose contact details are at the bottom of this report.

GUC distributes an amount of money each year to individuals, and to organisations that can help individuals, who live in the Parish of Godstone.

Most of the money received comes from the Henry Smith Charity: the amount is similar each year: this year it was £13,700, a substantial increase on previous, to reflect the rising cost of living. The rest of the income is from funds invested in CCLA Investment Management Ltd.

The Henry Smith Charity define their criteria such that we can give to individuals and families who are poor, elderly and/or disabled: we can give to organisations that directly help individuals who live in Godstone Parish: we can also help with alterations to public buildings when improving their disabled access.

As well as this we currently meet three times a year and give food vouchers. We continue to use Morrisons gift cards and Godstone local shop vouchers which helps our local shops. Each family receives vouchers or gift cards to exchange for goods, the amounts of which are decided at the meetings, then issued by the Clerk and delivered to the parishioners by the Trustees to help with extra expenditure at Christmas and Easter. In addition, we have issued vouchers or gift cards for the children to help with funding meals during the long summer holidays. Over the past year/ 18 months the vouchers were £50 per household with an additional £50 for each child under 18 years per household.

Organisations who would like a grant should apply in writing to the Clerk directly or via the Parish Council. When considering an application for a grant, particularly from an organisation, the Trustees must be satisfied that the Parishioners of Godstone will benefit.

Anyone can apply for a grant or to join the voucher scheme, whether for themselves or on behalf of someone else. If the criteria are met GUC can help with grants for things like school uniform, school trips, essential medical equipment, essential domestic equipment etc. We help by paying directly to the supplier of the goods required, no money is given directly to an individual or family. No application is considered in connection with payment of debts, hire purchase commitments or fines; this is specified by the Henry Smith Charity.
