There were 59 members of public present

Mrs F Gresser presented the GVA Report and Recommendations on Tandridge Local Plan. The GVA will distribute to every house in Godstone by week end 9 February.

A number of residents expressed their concern that they had only heard about Trandridge District Council Local Plan Consultation this week and were worried about how this could impact their communities. ie Why had a Neighbourhood Plan not been carried out.

The Chairman suggested a public meeting to be held on Monday 8th February, inviting speakers from Tandridge District council and other interested parties, this would give residents a chance to hear proposals and ask questions.

Cllr Windsor informed the meeting that the works on North South A22 by pass should be complete by 14 February. Grant - Alan White of GVA will bid for Cllr Windsor's grant to undertake an Air Pollution Survey, if noone else is successful.

Yellow lines to be painted in Blindley Heath, this job is on the list - she will chase.

South Godstone parking. A large number of cars are parking on yellow lines at Hunter Chase especially at school picking up time. Cllr Windsor will inform relevant authority.

Owners unhappy with the way it has been repaired and notice that the road now subsides down to the left hand side due to the fact that the pipe had burst beneath the road and was like this for about five days during the rainy period. 7.2. Any other financial matters

1. <u>Summary Financial Report to 31 December 2016</u> The summary was signed and dated by the Chair. A copy of the accounting records for November, including the bank statement, incorporating the bank reconciliation to be available at the meeting for examination.

Cllr White explained that the Lloyds Bank still had not changed signatories. Some letters dated November 2015 had been sent to the previous Clerks home address - hopefully this has now been rectified.

Cllr Davis suggested that if these issues with the bank were not resolved in the next 2 weeks we should close the account and move to another bank as this matter had been going on since last August.

2. South Godstone Sports & Community Association

To consider a request for a Grant for demountable Staging total cost would be £2,168.40. Cllr Hubery and White declared an interest. It was decided to wait until an application form had been formalised and then consider application.

3. Blindley Heath Cricket Club

To consider a request for £400 toward replacement of 10 oak posts at the common.

It was agreed to award this Grant as Blindley Heath do not receive very much from the Parish Council.

8. Greens, Commons and Land

8.1 Allotments

1. Review of allotments

Cllr Gardner met with the nephew of owner of Salisbury Road Allotments. Please see seperate sheet of proposals put forward.

Cllr McLoughlin will see quotations to clear and tidying up the allotments at Salisbury Road

Hilly Fields - owner happy to continue with Parish Council renting £300.00 per annum. Councillors agreed to continue with the lease for another year. However, as the rent from 9 people who have allotments, does not cover the cost of rental, they recommended that the lease will not be renewed after 2017 and notice given.

8.2 Godstone Green

1. Play Area Inspection Report

Hand holds have been delivered and contractor asked to fix. Also to lay more sand as foundation material is showing through.

2. Leaves on the Green

Godstone Preservation Society asked if the clearing of the leaves around the Green could be undertaken by the Parish Council. Councillors agreed to this proposal. Cllr Gardner pointed out this the contractor was able to use a 'leaf collecting' device to attached to his tractor. It is very important to collect leaves as Horsechestnut leaves currently carry Leaf Miner disease.

3. Club Road Car Park

Contractor has filled in some potholes. More have appeared and he will be asked to fill these as well. It was agreed that at present we should not re tarmacing this area.

8.3 Hilly Fields

1. Proposed car park.

Cllr Gardner reported that Tandridge Council did not regard this proposal as a special case and need evidence of increase in economic viability of local business' to prove increase of income to business. Cllr Gardner had drafted a letter to be sent to all village based business' All agreed with the contend. Cllr Gardner will arrange delivery of letters.

8.4 Blindley Heath

1. Memorial Tree

Plaque has been received Cllr Faulkner will instruct Contractor to fix. Cost will be reinbursed by Sutton and East Surrey Water Company

2. Notice Board

Cllr Faulkner recommended that this be resited to St John's Church as the car park at Forman Institute is very busy. All Councillors agreed.

3. Pond by Cricket Club

Contractor as cancelled 2 meetings. Cllr Faulkner and Hubery to chase, to note £3,000 in budget for this work.

8.5 Tilburstow Hill Common

Car Park at the Enterdent - A complaint from a local resident had been received complaining about the state the car park is in. Cllrs Davis and Gardner inspected car park and could not see a problem. All agreed that the draft letter by Cllr Gilman should not therefore be sent. They agreed take legal advice re parking and wording of disclaimer should a tree fall down and damage cars left in an area that has become a parking area.

9.3 Collapsed tomb in St Nicholas' Churchyard

A quotation received from Stonecrest Memorials which is £2750.00+VAT. The solution is sound and also approved local supplier recommended by other local councils. In view of the urgent need to take action for safety reasons, a majority of councillors agreed to go ahead on a non competitive basis. It was agreed that Cllr M McLoughlin would over see the work and Cllr Gardner will sign off

- 9.4 Rubbish in burial grounds Cllr McLoughlin reported that there is a large amount of plastic waste in the bin area of the churchyard and suggested that we reinstate the Biffa contract to have this removed on a regular basis. Our contractor would be asked to put the bins out and take them in again after they have been emptied. Clerk to obtain costings
