Apologies were received from the Community Police, Nick Childs

Three members of the public attended, Mr Alan White, TAG to outline background and the amount of funding needed of a grant application for Air Quality Monitoring, if successful in obtaining funding the machine will be located on Fairalls building in High Street and hopefully will include local school children in the monitoring process.

Mrs Windsor introducted, Mrs Marjory Broughton who will be standing for the Tandridge District Council as a UKIP candidate.

Mrs P Rodgers, was a former clerk and is consultant in Parish Office.

Mrs H Windsor thanked the Parish Council for organising at short notice, the Public Meeting for Tandridge District Council Local Plan Consultation. The meeting was needed and much appreicated.

A complainted had been received from a local resident about heavy goods vehicles travelling a high speeds along Tilburstow Hill Road. It would help if residents could obtain Reg No of offending HGV's and times. Even though there are time restrictions on movement of HGV's these are not adhered to to the company's operating from Lambs site.

The A22 near Wonham House is flooded after heavy rain. Mrs Windsor said SCC are trying to address this. Councillors suggested the culvert needs clearing out also an underground spring runs here.

Cllrs asked Mrs Windsor if she could arrange for the culvert in Ray Lane to be cleared Mrs Windsor said if any Councillor was unhappy with the response from Surrey County Council re work A22 by pass they perhaps should write to the Council in time for their Local Committee meeting on Wednesday 23 March.

The Chairman thanked Mrs Windsor for signs that had been erected for South Godstone Sports Club.

5. Reports

5.1 Action taken - Letter sent to Cllr D Hodge Leader County Council re traffic problems caused by closure of north / south lane A22 from M25 Junction to Oxted Road - response received

Cllr Gardner complained that the reply received Cllr David Hodge, in reponse to ours complaining about the amount of time and disruption caused by the roadworks on north / south A22 by pass, was not worth the paper it was written on. It was felt that SCC Engineers should have been aware of the problems that could arise from the soil type the road was built on from the beginning of the project had these problems been addressed at the start of the project it would not have taken so long.

5.2 Clerk's Report

1. Should the Parish Council buy a Commemorative Medal for each child in the schools in the Parish? The cost is £1.99 each + £7.50 postage. The total cost would depend on the number of children.

After discussion it was unanimously decided that a one off Grant could be given to each school would be more appropriate and better use of money.

Parish Hall to consider a grant for kitchen refurbishment and replacement of the flooring in the main hall. Councillors felt this would be a major refurbishment we would not have sufficient funds for this whole project. Grant declined.

to consider £1,000 towards cost of demountable staging. This was granted as the building is well used by the community.

6. Grant Request from GVA To set up monitoring for Air Quality. Up to £1,000 was agreed for this project if required. [at the time GAV were sourcing other funding options]

- to agree renewal of Affiliation Fee the amount of £10.00 was agreed.

8. Greens, Commons and Land

8.1 Allotments

1. Review of allotments

Hilly Fields - Owners have asked if we would like to renew for 3 years. Also pay for Agreement cost for new lease this would be £450.00 + VAT. Cllrs felt that this amount is rather large and Clerk asked to contact Hedley's for another quote. The previous decision to not renew the lease was taken on incorrect information, due consideration was not considered to give notice to current allotment holders, or where on the waiting list for Salisbury Road Allotments would they be placed, therefore we need to renew lease. Salisbury Road - Need to establish whether we are legally bound by the convenant originally imposed on the site. This will involve legal fees and permission is sought to go ahead with this investigation. It was agreed to consult solicitors to clarify this. Hedges are overgrown on boundary with Fairalls yard. Clerk to write to Fairalls to ask this hedge be cut.
