	1.1 A resident raised a concern relating to planning application 2025/611 – the resident advised they attended the Planning Committee Meeting at Tandridge District Council (TDC) on 11 <sup>th</sup> December. The resident raised their concerns about this application at the meeting but was disappointed that the District Cllrs representing Godstone Ward did not raise any concerns at the meeting.
