Open Forum

M Alan said that Tandridge District Council had updated the community on savings. What have the Parish Council managed to save over the last 3 years. The Chairman said they have reduced the overhead for running the office and hope to give more money to the three villages once the needs have been confirmed, the villages can apply for a grant for a project. The largest project at present will be the car park in Hilly Fields should planning permission be granted.

Mrs Gresser on behalf of the GVA said they have had a serious and detailed look at Tandridge Distict Councils Local Plan. Tandridge take no more notice of organisations than they do of an individuals commenting. Mrs Gresser stressed that comments on this Plan is important as it will be used as a framework for Tandridge in the future. She also said it is worthwhile looking a 'OLRG' they will be sending out an A4 leaflet to households. Mrs Gresser said perhaps GPC could consider something similar. Tandridge are looking to downgrade some Green Belt land. Tandridge need to build more houses they receive from the Government £50,000 for every house built. The Parish Council welcomed these comments and are happy to work with the GVA on this.

A Rabbetts who maintains the PC's website as it needs restructuring and confirmation as to who owns the domain name. We could re name using 'gov.'

Cllr H Windsor reported that work on the A22 North / South by pass will take longer that originally planned. She is receiving regular updates on the situation, the impact on traffic is extremely bad, traffic backs up to Whyteleafe on A22 and past Junction 7 on M25. Work cannot be undertaken when raining. The workforce is working 24/7. Bletchingly Parish Council are making a complaint and suggest we do the same.

Cllr Windsor said she has an allocation to help fund A25 Air Quality Monitoring which she think is an excellent idea. She has somewhere around £2,200 to £3,000 which has to be spent by the end of February. If anyone knows what is needed and can decided who this is to be allocated to. She would like to know what people would like to do please as she has had one other request from S. Godstone. Cllr Windsor does need to know if this funding can be used urgently.

8. Greens, Commons and Land - Cllr Davis declared an interest Salisbury Road

8.1 <u>Allotments</u> Salisbury Road AllotmentsCllr McLoughlin advised he had obtained three quotations from to have Lime and Attocher tree trimmed and to remove diseased and dying wood. Having compaired all three quotations, the company offering the best value is SJT Trackforce Treecare at a cost of £380 + VAT. Cllrs Davis and Gilman abstained.

Separate quotations will be sought for clearing of Rubbish on the site.

8.2 Parish Council needs to confirm the right of way it has to the Salisbury Road allotment site. A letter has been sent to the owner of the site seeking clarification on right of way and asking what [if any] their future plans for the site maybe.

8.3 Hilly Fields ["Hare & Hounds"]

A letter has been sent to the owner of the site asking if they are intending to renew the lease that expires March 2016. It was noted that the rent for this site exceeded the rental received.

The Enterdent

At the Finance meeting in December it was agreed that subject to the terms in the wayleave that might prevent or control increases all wayleave charges would increase by 5% from 1st October 2016. It would be necessary to check each wayleave agreement before sending out invoices.

The Enterdent would increase to £25 for a small plot and £50 for a large plot from 1st April 2016. Councillor Gillman reminded the meeting that these charges have not increased since 2006 and the increase is less than inflation over that period. There is a large plot 'J' but as only half is used - the rest is full of brambles etc it was agreed to charge only £30.00. The Parish Council agreed with these

8.4 Godstone Green

1. <u>Play Area Inspection Report</u> - Remedial actions following this report dated September need to be taken

2. Christmas Lights - £1035.00 had so far been received from local Businesses following an appeal for maintenance of Christmas Lights in Godstone. Councillors thanked all businesses who had donated, the Chairman had sent out letters of thanks.

3. Club Road Car Park

To note correspondence from a local resident concerning defective tarmac and lack of illumination. It was agreed that our controactor would fill in the pot holes.

8.5 Hilly Fields

1. Proposed car park

Feedback from the Planners at Tandridge Council was initially unfavourable as the site is in the Green Belt. However, there is strong local support from local district councillors and the decision is being referred to the full planning committee rather than being taken under delegated powers by officials, this meeting will be held in January. Cllr Nick Childs will speak in favour of this proposal.

Currently Tandridge District Council are looking to put a car park in the Depot in Oxted Road. This is thought not a useful idea as it is too far from the centre of the village and would not be used. It would also have to be locked up when the Depot is not in use! A Traffic Survey Report has been received this justifies why we need and the best place to site the car park. Surrey Highways have said this is feasible and would be good for the village

8.6 Blindley Heath

<u>1. Memorial Tree</u> - Has been planted. A plaque will be ordered and then invoices for all items plus cost of planning, will be sent to East Surrey Water Company for payment to reimburse Parish Council.

2. Notice Board

Quotation from Woodland Joinery had been obtained this amounted to £2595.00 + VAT. It was agreed to obtain another quotation. The telephone kiosk is still ongoing.

3. Pond by Cricket Club

Cllr Faulkner advised that this work should not begin until Spring / Summer 2016

4. Blindley Heath Liaison Group

To note draft minutes of the BHLG meeting held on 27th October Transfer of ring fenced funds from Godstone Parish Council to Surrey Wildlife Trust. There is £7,900K in restricted funds from the HLS grant which the Parish Council is still

holding. SWT are frustrated that Councillors are reluctant to hand this money over to them. The Ranger's report has recorded 17.5 man days charged at £316 per day, they would therefore submited a formal invoice to GPC for £5,530. This money is not trhe Parish Counci's money. The Higher Level Stewardship agreement will expire in 2017 and SWT will make an application on behalf of GPC.

8.7 Tilburstow Hill Common

The Clerk had been trying to contact Surrey Wildlife but no one was available until after Christmas. She had contacted Woodland Trust but they were not interested in developing and managing the area professionally within a 5-10 year plan, in conjunction with adjoining Rabies Heath Road site.

Councillor McLoughlin reported that a Wayleave had been granted to Fairalls for their Taylor's Hill Depot for 25 years from 13 May 2005 for £4,000.

It was agreed to have a separate site meeting with councillors at the Enterdent car park to discuss parking, trees etc. As car parks are not allowed on Common Lane the car park is technically illegal. Who would be liable if vehicles are parked and damaged?
